What can your troop learn and DO at Tiffany Chiu's Mystic Canyon Stable to meet their badge requirements?

Your troop can just come to ride and/or learn horsemanship through **hands-on horsecare** by **handling, grooming** and **tacking up your own mount!** From putting on the halter and lead rope to saddling and bridling, you'll learn how to care for this horse/pony as if it were your own! **Responsible animal stewardship!**

In fact, this horse/pony will be yours for the entire time you are at our barn!

Not to mention you'll get to **ride!** And then **untack** and **tidy up** after your horse!

CHOOSE from 3 Options:

**A. 90 minutes group lesson for 2 riders/mount,** up to 16 riders on 8 mounts OR

**B. 2 hours group lesson for 3 riders/mount,** up to 24 riders on 8 mounts

~ \$45 each rider

(includes grooming, handling, tacking up, riding, untacking, plus while the other rider is riding you'll have time to muck stall, clean tack, learn parts of the bridle and saddle plus handle our other critters {rabbits, chickens})

**C. 90 minutes group lesson for 8 riders on 8 mounts**

~ \$75 each rider

(same as above with riders on their personal mount without taking turns with another rider, not sharing ride time or handling, doing all the work and ride one rider/mount)

Your Troop will schedule to arrive on a Saturday at 12:30. Come in to the barn to find boots/helmets that fit from our loaner supply. At 1 pm we'll do a safety debriefing, assign Riders to Horses/Ponies with Helpers, then let Helpers assist Riders in badge requirements while working with their mount.

**CANCELLATIONS AND RESCHEDULING made with less than 24 hours notice prior to lesson start time, the FULL COST of the lesson is due, regardless of reason for cancellation (such as illness, emergency, no show, etc.).**

I save ponies for and rely on riders by scheduling in advance, filling open spots and juggling everyone's calendars to stay in business doing what I love. Thank you for your help and consideration. **Sadly camp days missed cannot be made up.**

**Lessons run rain or shine! We ride in the rain! Tiff provides ponchos. If Tiff decides the weather is unsafe for riding, then she conducts indoor dismounted discussion lessons covering various topics depending on the students' interests.**

**RELEASE AND HOLD HARMLESS AGREEMENT**

I agree to and do release, discharge and promise not to sue Tiffany Chiu, Lisa Correa, Associates, Mary Jo Curwen, and/or Colin Chiu for any loss, liability, damage, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property or any horse owned by me or to any family member or spectator accompanying me, whether such may occur on the premises or elsewhere.

Further, I agree to and promise to indemnify and save and hold harmless Tiffany Chiu, Lisa Correa, Associates, Mary Jo Curwen, and/or Colin Chiu from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with riding lessons or with my presence on the premises or with the presence on the premises of any person accompanying me.

I agree that this Release and Hold Harmless Agreement is governed by the laws of the State of California and is intended to be as broad and inclusive as is permitted by California law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of this Agreement shall not be affected or impaired in any way and shall continue in full and legal force and effect.
